Sanders announced his retirement, effective Feb. 14, after 35 years of police service. Cheatwood said the agency will greatly miss Sanders and his smile, along with his positive outlook on life and the community. "On Jan. 31 of this year, I tasked the Morale Board with naming the American Legion Post 555 Officer of the Year for 2020.

Private Medical Evidence

The Department of Veterans Affairs encourages all Veterans to submit their private medical records for consideration during the processing of their benefits claim. VA values evidence from your private treatment providers because they are familiar with your medical history, often over a long period of time. VA appreciates the trusted and special relationship between private treatment providers and their Veteran/patients.

How To Submit Private Medical Evidence for Your VA Claim

Talk to your healthcare provider (family physician, urgent care visits, any Tricarecovered treatment after discharge) and explain that you are filing a claim for VA benefits; discuss the conditions for which you are filing a claim.

• If required, complete your healthcare provider's release of information form, obtain your records, and submit with your claim, OR

• Complete VA Form 21-4142, Authorization to Disclose Information to the De-

How To Incorporate Federal Records with Your VA Claim

Tell us about your Federal records (from any federal agency*) and we will gather these on your behalf. If you received treatment at a military hospital or clinic after your discharge, please include facility information and the date ranges of your medical treatment records for your claimed conditions when completing VA Forms 21-4142 and 21-4142a.

*It is not necessary for you to submit your Service Treatment Records (STRs) or treatment records from a VA medical facility as we have access to these records.

Claims Assistance

We encourage all Veterans to work with an accredited organization for assistance in completing claims for VA benefits. A list of accredited organizations can be found on the Office of General Counsel site at this link: Search the VA Office of the General Counsel's list.



During July, in cooperation with Ron Koonce, there is now a Wreaths Across America tab on the Post 555 website under "Programs". When opened, this tab includes a write-up on the background of the Wreaths Across America Program as well as a copy of the current donation form that can be downloaded. Anyone wishing to make a donation can download and complete the form, fill-out their check as indicated along the left margin of the form, and mail it to the Post address. Chuck will make sure it gets processed.

One very important thing I want to point out is the fact that we more than likely will NOT be having our annual Thanksgiving Dinner/Meeting due to the COVID-19 restriction of not allowing a large group of people together in one place. We typically receive 40-50% of our contributions during this event, and Chuck, Eldon, and I are all very concerned that we will not be able to meet our goal of \$3,600. With this in mind, please do the best you can to send in your donations ASAP that you normally might have submitted at that event. Chuck reported to me that we have received \$600 or 16.67% of our goal as of July 19, 2020 (refer to the WAA Campaign Summary prepared by Chuck Kiser), but a little birdie told me that there was a check for an additional \$200 on its way, so that will adjust our figures in the positive direction for sure!!
